Plan Description:

1) In 2006, a total of 25,494 home loans were made in Palm Beach County, of which 8,354 (32.8%) were sub-prime loans; 2) As of September 30, 2008 there were 12,000 foreclosed-upon properties in Palm Beach County. 3) More recent information has indicated increasing numbers of foreclosures in the 1st quarter of 2009.

Recovery Needs:

Using HUD-provided data, Palm Beach County has identified areas with the greatest need for NSP assistance based on the following factors:

- areas with greatest percentage of home foreclosures;
- areas with the highest percentage of homes financed by subprime mortgages;
- areas identified by the County as likely to face significant rises in the incidences of home foreclosures; and
- areas within the County with the highest concentrations of low- and moderate-income persons.

NSP funds will be used exclusively in these identified areas to arrest the deteriorating effects of home foreclosures

Overall Progress Narrative:

NSP1 activities have begun. The Palm Beach County First Mortgage Program (Activities NS20 and NS21) was opened to the public and over 300 applications for first mortgages to acquire foreclosed homes have been received and are currently being reviewed. The County is in negotiations with property owners to acquire 2 properties for redevelopment as County Homeless Resource Centers (Activities NS30A and NS30B). Additionally, a \$5M NSP RFP has been issued to solicit subgrantees who will acquire/rehab foreclosed residential properties for resale or rental. Twelve proposals were received as a result of the RFP and are currently being reviewed. Staff has attended NSP trainings, and is performing NSP administrative functions (NS10).
