Palm Beach County Department of Economic Sustainability (DES) proposes to amend its Action Plan for Fiscal Year 2010-2011 as follows:

Proposed 28th Amendment to FY 2010-2011 Action Plan

The U.S. Department of Housing and Urban Development through the Neighborhood Stabilization Program 3 made available funds of \$11,264,172 to Palm Beach County.

The proposed 28th Amendment seeks to reduce the Acquisition/Rehabilitation activity by \$249,753 from \$1,408,021.50 to \$1,158,268.50. These funds will be re-programmed to the Glades Area Demolition and Clearance Activity for an increase in total activity budget from \$664,000 to \$913,753.

This Amendment will be available for public inspection at DES, and will become final after a 15-day public comment period. All comments must be in writing and received by DES Strategic Planning Section at 100 Australian Avenue, Suite 500, West Palm Beach, FL 33406, no later than November 3rd, 2013.
