

# **INFORMATION ABOUT THE Palm Beach County Geography and Driver Information Test**

Before you can receive your first Driver's Identification Badge in Palm Beach County or if your ID badge has expired for more than one year, you must pass the "Palm Beach County Geography and Driver Information Test". The study sheet which we provide to you has a total of 44 true statements. The test you will be given will consist of 10 of these. You must answer 7 of the 10 questions correctly to pass the test. Each question and 4 possible answers will be given to you orally on the computer while you view a photo which relates to the question.

If you have a good understanding of the following facts about Palm Beach County geography, driver laws and the Vehicle for Hire Ordinance – you should have no problems with the test.

1. John F. Kennedy Medical Center is located on Congress Avenue in Atlantis.
2. Good Samaritan Hospital is located on Flagler Drive in West Palm Beach.
3. Delray Medical Center is located in Delray Beach.
4. Palms West Hospital is located on Southern Boulevard.
5. St. Mary's Hospital is located on 45<sup>th</sup> Street in West Palm Beach.
6. The Breaker's Hotel is located in Palm Beach.
7. To get to the Breakers Hotel from Palm Beach International Airport, you must drive east through West Palm Beach.
8. You can get to Palm Beach International Airport via, I-95, Congress Avenue and Belvedere Road.
9. Your response to a passenger choking in your vehicle should be to make a phone call to Emergency 911.
10. The Amphitheatre at the South Florida Fairgrounds, formally known as the Sound Advice Amphitheatre, Cruzan Amphitheatre, and Perfect Vodka Amphitheatre is located west of the Florida Turnpike.
11. The Palm Beach County Vehicle for Hire Driver I.D. Badges should be worn at all times while on duty.
12. The Kravis Center is located near the Palm Beach County Convention Center, City Place and the West Palm Beach Tri-Rail Station.
13. The main Palm Beach County Courthouse in West Palm Beach is located on Dixie Highway.
14. The shortest route to get to Florida's Turnpike from Palm Beach International Airport is to go west on Southern Boulevard.
15. The Palm Beach County Consumer Affairs office is located at Military Trail between Southern Boulevard and Gun Club Road.
16. In Palm Beach County you must stop driving a for-hire vehicle after cumulatively working for 12 hours.
17. Century Village in West Palm Beach is close to the Florida Turnpike.
18. U.S. Highway 1 is also known as Broadway in Riviera Beach, Dixie Highway in Lake Worth and Federal Highway in Boca Raton.
19. The Tri-Rail Station in downtown West Palm Beach is located on Tamarind Avenue, near the Kravis Center and near Rosemary Square, formally known as City Place.
20. The Palm Beach County Sheriff's Office and County Jail are located in West Palm Beach on Gun Club Road.
21. Belvedere Road is located in central Palm Beach County.
22. You can take Southern Boulevard west to Belle Glade.
23. The Palm Beach County Vehicle for Hire Driver's Identification Badge expires 2 years from date of application.
24. The Palm Beach County Convention Center is located on Okeechobee Boulevard in West Palm Beach.
25. Rosemary Square, formally known as City Place, is located in West Palm Beach.
26. Indiantown Road is located in the Town of Jupiter.
27. Emergency 911 is the local emergency assistance phone number.

28. The city at the southern end of Palm Beach County is Boca Raton.
29. Tri-Rail is a passenger rail transportation system linking the Tri-Counties – Palm Beach, Broward and Miami-Dade.
30. Southern Boulevard runs east and west, has a Florida Turnpike entrance/exit and crosses State Road 7/U.S. 441.
31. The North County Courthouse is located on PGA Boulevard in Palm Beach Gardens.
32. The Port of Palm Beach is located in Riviera Beach.
33. In Palm Beach County, A1A is a two-lane north-south thoroughfare near the Atlantic Ocean.
34. Palm Beach Lakes Boulevard is an east-west thoroughfare located in West Palm Beach.
35. Forest Hill Boulevard is an east-west thoroughfare located in West Palm Beach.
36. The South Florida Fair is located on Southern Boulevard.
37. Palm Beach County is the largest county in Florida.
38. The Palm Beach Resort and Spa (formerly the Ritz Carlton Hotel) is located in Manalapan.
39. Palm Beach State College has campuses in Lake Worth, Belle Glade and Palm Beach Gardens.
40. This sign means that the road is slippery when wet.

41. This sign means to watch for pedestrians.



42. If you are on a road with this sign, it means you are traveling on Interstate 95.



43. This sign means there is a hospital nearby.



44. This sign means that the road is a hurricane evacuation route.



This test is required by Palm Beach County Code Chapter 19, Article IX-Vehicles for Hire, Section 19-227, paragraph 23(O). If you fail to answer 7 of the 10 questions correctly, you may schedule a re-examination within 30 days at no additional charge. If you fail the test for the second time, it will be necessary for you wait 30 days and then you may reapply and must repay all the required driver application fees. The driver application and testing process begins again upon payment of the required fees.
